Purpose: This Note to Industry (NTI) seeks to inform medical practitioners who are registered under the Medical Practitioners and Dentists Act (Chapter 112) in Brunei Darussalam on their legal duty to report occupational disease to the Authority.

The Safety, Health and Environment National Authority (SHENA) would like to remind all registered medical practitioners practicing within Brunei Darussalam on the legal requirement under Regulation 6(2) of the Workplace Safety and Health (Incident Reporting) Regulations, 2014 to report any cases of occupational disease to the Authority not later than 10 days after the diagnosis.

Reporting of occupational disease can be done online by completing the Initial Incident Notification form available on the SHENA website <u>www.shena.gov.bn</u> and accessible via the QR code as appeared in **Appendix A.** The list of reportable Occupational Diseases is included as **Appendix B, as specified under the Third Schedule of the current Workplace Safety and Health Order, 2009.**

Medical practitioners are also advised to refer any suspected Occupational Disease via a referral letter to Occupational Health Clinic, Ministry of Health, Level 1, Health Screening Centre, Jalan Delima Dua, Berakas BB2313 or via email: <u>occuphealth@moh.gov.bn</u>. The referral letter is to include the patient's contact details. Please refer to **Appendix C** for the process flowchart for referral and reporting.

Under-reporting of occupational diseases continues to be a nationwide concern as it hinders the necessary regulatory action required to ensure the adequate protection of workers and their working environment. Based on statistics received from the Ministry of Health, a total of <u>108 cases</u> of occupational diseases were recorded between 2017-2022.

Any registered medical practitioner who fails to report occupational diseases to the Authority is in contravention of Regulation 6(2) of the Workplace Safety and Health (Incident Reporting) Regulations, 2014 is guilty of an offence liable on conviction to a fine not exceeding \$5,000 for the first offence and for further subsequent offences, a fine not exceeding \$10,000 or imprisonment for a term not exceeding 6 months or both.
