Purpose:

The Safety, Health and Environment National Authority (SHENA) hereby refers to the Note to Industry, 2020/NTI/11 titled "Submission of COMAH related documents as required under Workplace Safety and Health (Facilities) (Control of Major Accident Hazards) Regulations, 2013" that was issued on 29th June 2020 in which SHENA informed all Duty Holders of Oil and Gas and Petrochemical Plant Operators to revert to the previous arrangement of physically submitting one (1) hard copy and two (2) soft copies [via compact disc (CD)] of their COMAH related documents to SHENA.

SHENA hereby informs that effective from the date of this Note to Industry, all Duty Holders of Oil and Gas and Petrochemical Plant Operators **are no longer required to submit a HARDCOPY document for the final submission of the Safety Case process.** SHENA will only require physical submission of two (2) soft copies [via 2 compact discs (CD) or 2 pendrives] of their COMAH related documents and marked **SAFETY CASE** to:
